New Vehicle Fees

Whenever a transfer of ownership is recorded with the Department of Motor Vehicles, all fees due to the state must be paid. All fees required by the state to register a vehicle and transfer ownership may be charged to a customer. This includes license and registration fees, other miscellaneous fees, penalties and duplicate documentation fees. **Penalties that accrue due to a dealer's failure to pay fees on time cannot be passed on to the buyer.**

A few things to note when it comes to the rating of the DMV fees:

SMOG ABATEMENT: Smog Abatement Fee is NOT due on DIESELS, ELECTRIC vehicles, or vehicles registered in NON-BIENNIAL SMOG AREAS.

SELLING PRICE: "SELLING PRICE" means: (1) For vehicles sold using LAW® 553-CA and 553-CA-ARB retail installment sale contracts, Cash Price Vehicle (line 1.A.1.) + Cash Price Accessories (line 1.A.2.) + Theft Deterrent Devices + Surface Protection Products (lines 1.D.1. through 1.E.2.); (2) For leased vehicles, "agreed upon value" + accessories.

Common Fee Exemptions common vehicle license fee exemptions: The following are the common vehicle fee exemptions for both new and used vehicle sales.

Nonresident Military	Nonresident military members and their spouses are exempted from the vehicle license fee (VLF) portion of the initial registration fees and the Transportation Improvement Fee (TIF). All other fees, including the county fee are due.
Native American	Federally-recognized Native American tribes or tribal members residing on a federal reservation or rancheria are exempted from the vehicle license fee (VLF). In addition, vehicles registered to a federally-recognized tribe and operated exclusively on tribal land are exempt from all fees other than the \$68 Registration fee.
Disabled Veteran	Disabled veterans are exempted from all fees (except duplicate plate/sticker) for one vehicle (auto, motorcycle or commercial 8,000 lbs or less), provided the vehicle displays disabled veteran license plates and is not used for hire or compensation.
Disabled Commercial Vehicles	Disabled individuals are exempted from the weight fee for one commercial vehicle weighing 8,000 lbs or less.
Exempt Vehicles	Vehicles registered or leased to qualified state, federal or local agencies are exempted from all registration fees.


Used Vehicle Fees

SMOG ABATEMENT FEE of \$20 is generally collected on first six model years — 2023, 2022, 2021, 2020, 2019, and 2018 — when paying renewal fees and the vehicle is to be registered in a biennial smog area.

SMOG ABATEMENT FEE of \$25 is generally collected on model years between seven and eight years old — 2017, 2016 — when paying renewal fees and the vehicle is to be registered in a biennial smog area.

SMOG EXEMPTION FEE of \$8 is generally collected on first four model years — 2023, 2022, 2021, and 2020 — in lieu of a smog certification fee. This fee should NOT be collected on vehicles older than four model years, prior out-of-state, diesels, or electric vehicles, or vehicles which would not otherwise require a smog certification.

NOTE: Smog Abatement Fee should NOT be collected on vehicles older than eight model years, prior out-of-state vehicles, vehicles to be registered in a non-biennial smog area, or on diesel or electric vehicles.
